Entry Fee: \$15 per boat advance online entry by noon June 18 or \$20 per boat onsite.
Register online at www.marshallcountyanglers.com

Onsite registration starts at **4:30 a.m.** at the MC Anglers trailer by the launch ramp.

Morning meeting will be held on the fuel dock at **5:15 a.m.** **Takeoff** will start at **5:30 a.m.**
All boats must idle by MCHS officials on the fuel dock for livewell check as their boat number is called.

Afternoon check-in is at **12:30 p.m.** at the fuel dock. A MCHS official will collect boat numbers. Weigh-in will be held at the MC Anglers trailer. Trailering is permitted.

Trophies awarded to top 3 teams and big bass.

MC Anglers rules apply, except:

- 3-fish limit instead of five.
- Participation is open to all father/son, father/daughter, parent/child, mentor/student combinations of middle-school age or older.
- Student anglers can fish with their teammate and boat captain (three people per boat) or just their boat captain (two people per boat) provided the boat captain is a relative or legal guardian. Students cannot fish alone.
- Boat captains **CAN** fish this tournament only.

Off-limits and size restrictions:

- Inside the breakwall at Moors is off-limits. All other Kentucky Lake and Lake Barkley waters are open, subject to MC Anglers rules. No locking.
- All bass must be a minimum of 15 inches.
- 8-ounce dead fish penalty.

PARTICIPANT RELEASE OF LIABILITY — READ BEFORE SIGNING
